

# DUY - LICENSE TRANSFER REQUEST FORM



Dear user,

Please use this form in order to transfer any of your transferrable licenses to another user. You should complete this form for every individual product you have. If you have a bundle, complete it only once. Email it to [registrations@duy.com](mailto:registrations@duy.com) or to the fax number at the bottom of this page.

The following requirements must be met in their entirety in order to be able to transfer your license:

1. If your license is currently on an iLok, we will need your cooperation in order to de-authorize your USB key via ilok.com. Licenses will be transferred to the new user once the complete procedure has been followed.
2. In order to transfer a license, there is a administration fee involved. These costs haven't changed since 1 January 2003 and are the following: EUR 40 to transfer a TDM bundle, EUR 30 to transfer an individual TDM plug-in, EUR 30 to transfer a native bundle or more than one native product, and EUR 20 to transfer an individual native product. For further information, please read the Software License Agreement and <http://www.duystore.com/com/transferpolicy.html>. It's a decision of the registered user to share the cost of this fee between the seller and the buyer, or have it paid in full by either of them. 3. Transferrable licenses are those that belong to purchased products, correctly registered through DUY at the time of purchase. The new user will inherit the software in the same state (version & update/upgrade status) as the current customer. Obviously, no Not For Resale or Demo copies can be transferred to anyone.
